Mr. Finch is one of the few people who knows common sense for knowing who to defend in this situation. In Maycomb County, all the whites are "good" and all the blacks are "bad" but that is not actually right because white folks make mistakes also. Everyone knows that most of the people just blame their mistakes on Tom's kind of folks because getting punished and the reputation of being a "good"

person will be ruined.

In conclusion, the trial was just unjust for Tom and this case should teach everyone in Maycomb how injustice should be stopped so that nobody else has to experience this sort of unjust again. Everyone in the world should be treated equally and no innocent person should be accused of something that he/she did not do especially because of their skin color.
