## A Shot for the Colored: The Tom Robinson Trial

By giving the verdict that Tom is guilty even though they know that Tom is not.

They thought that they knew all the facts about colored people just because they had to live with them. But they don't. The colored people had a small glimmer of hope with the Tom Robinson trial. The thought that they might start down that road of equal rights and no discrimination, but that glimmer was shot, literally, when Tom died. They had to wrap their minds around the fact that they might be living in the same conditions as before, no rights and discrimination, for another 10, 20, who knows how many years.

Whites need to realize that they are not all high and mighty to the coloreds. The coloreds think poorly of us. They have stereotypes about us as well. They probably think that we all make them work til they drop or that all white girls, like Mayella Ewell for instance, tempt black men and then press charges. For this generation, though I'm hoping that the girls growing up now will learn from this situation and that they need to treat colored people with a good amount of respect.

We as whites need to reinvent ourselves to the coloreds and we need to spread this message out there to those who are low class or high class. The message being this; that we should change how we treat others and how we assume and make stereotypes about others. This message is what Atticus is telling us in the trial and courtroom. He is challenging the beliefs of everybody. Us, as the liberal citizens of Maycomb County, we need to tell others about this message of Atticus' and that we should

put this plan into action.
