It has strong references and literary works that it cites for its analysis, but its outdated figures don't address rap's presence in the 21st century.

The source tracks the commercial success of songs on the Billboard Hot 100, which helps quantify the popularity and trends of songs in the U.S. and understand the variety of music in the public eye. The source considers the many aspects surrounding musical evolution, including revolutions and societal changes, but it doesn't consider the different human demographics that can also alter popularity.

trials in its experiment that it uses to support its claim, but it doesn't discuss alternatives to songwriting, which might help support its statement more.

This helps consider the impact of a musician's life on the music they create. This can be used for working through the inspiration for songwriting as it is important to understand what things dictate the lyrics that come out as well as the overall sound of the song. The information is very recent, coming from an experiment done within the last couple of years, which can pair well with and contrast against the other outdated sources. This experiment had many subjects from different focus groups, as well as other research that it references, which supports the information in the source. The authors have various backgrounds, which can eliminate possible bias, but they only survey European and North American composers, which can leave a way for some biases toward those groups. The main idea of the source is that composers are constantly adapting to their environment and their creativity is rooted in their bodily experiences and environment. The source clearly explains how its findings are supported by the responses of its participants, but doesn't include a broad spectrum of identity for its participants.

The song subjects are a bit outdated but can help compare against modern-day ways of telling stories about political and social problems in music. The author has special connections with music in African-American communities due to their childhood, which might offer bias in their analysis. Still, they also consider the lyrics of different songs and the stories of their artists very carefully. It can support my desire to explain the history of different musical genres, as well as guide my analytical process. The source mainly investigates the different genres prevalent in black culture, such as gospel, rhythm and blues, and soul, but it also takes a deeper look into the meaning and controversies behind artists from the 60s and 70s. The source pays special attention to the history of black music but doesn't include more modern examples of the same storytelling methods.

This source explains sound engineering and music theory expertly but focuses primarily on the technological aspects as opposed to the other aspects incorporated into music production.
